<p>HB 4688 and SB 351 : Add "Sexual Orientation" and "Gender Identity or Expression" to Civil Rights Protections</p> <p>This bill would add "sexual orientation" and "gender identity or expression" as protected classes under the Elliott-Larsen civil rights protection law. <p>HB 5139 and SB 593 : Add "Gender Identity" and "Sexual Orientation" to Ethnic Intimidation Law</p> <p>This bill would add "sexual orientation" and "gender identity" as protected classes under the ethnic intimidation law, which authorizes penalties for someone who intimidates or harasses another person based on their identity.
